

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2 AND WHERGAS, the institution Rajeev Memorial College of Teacher Education, Kavumpadi, Thillenkeri, (P.O) Mattannur (Via), Kannur (Dt.) 670702, Kerala has by a request dt. 04.04.2019 requested for issuance of provisional revised recognition order for one basic unit in B.Ed which require additional facilities.
- 3. AND WHEREAS, it has been decided by the SRC in its 374th meeting held on 9th & 10th April, 2019 to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions:-
 - The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
 - 11. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, and 2014 and inform Regional Committees with required documents by October 31, 2015.
 - III. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of Inspection.
 - 1V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2017, the Southern Regional Committee, NCTE hereby issues Revised Provisional Recognition Order to Rajeev Memorial College of Teacher Education, Kavumpadi, Thillenkerl, (P.O) Mattannur (Via), Kannur(Dt.) 670702, Kerala for conducting B.Ed programme of two years duration with an annual intake of 50 for one basic unit of 50 students from the academic session 2019-20 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC within a period of one month from the date of issue of this order and fulfilment of the conditions mentioned at II & III within a period of one month.
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Rajeev Memorial Charitable Society, Kannur District, Kerala has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Rajeev Memorial College of Teacher Education, Mattanur, Kannur District — 670 702, Kerala for Secondary(B.Ed) course of one year duration with an annual intake of 100 (Hundred) Students.

- AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Rajeev Memorial College of Teacher Education, Mattanur, Kannur District 670 702, Kerala for conducting Secondary(B.Ed) course of one year duration with an annual intake of 100(Hundred) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
 - iv) The institution will ensure that <u>Principal and Seven</u> faculty member duly approved by the affiliating University are in position for an intake of <u>100</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update the Web-site as per provisions of NCTE 6.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
